TEA

OPERATIONS

The Tea business operates under Kipkebe Limited a fully owned subsidiary of Sasini PLC. It is domiciled in Nyamira County with parts in Kericho County west of the Rift Valley along Chepilat - Ikonge - C22 road. The core mandate is growing, manufacture and sale of black CTC teas through auction and private treaties both locally and overseas.

Our Tea is grown on four (4) estates namely Kipkebe, Kiptenden, Magura and Keritor and two (2) Factories; Kipkebe and Keritor. Total land area is estimated at 2,835.6 hectares out of which 1,434.57 hectares is under tea, 600 hectares under wood fuel, 99 hectares natural forest cover and 218 hectares under other tree species.

The factories have a combined annual installed production capacity of 15 million kilograms of made tea out of which fifty percent (50%) is sourced from individual outgrower farmers and company managed outgrower farms.

Our sustainable business demands that we embrace and employ breakthrough technologies in our operations. In this regard, the company has adopted advanced farming technology. Tea harvesting is undertaken by use of Self-Propelled Harvester (SPH) and Two-man Hand-held Machine (MTH). Application of fertilizer is carried out using Unmanned Aerial Vehicles (drones) while pruning is done by a Self-Propelled pruning machine.

Part of the revenue generated from our tea operations goes into supporting our environmental protection initiatives and have also developed learning and healthcare facilities as well as sunk boreholes for provision of clean water to the community.









About 99% of the produce, is exported to United Kingdom, Europe, Asia and Middle East Countries. The company's production activities are certified under various international recognized certification standards which encompass; Rainforest Forest Alliance and ISO 22000:2018 certified to assure our buyers of prudent employment of food safety handling techniques, quality products and traceability at all levels of production.

COFFEE OPERATIONS

The coffee plantations are situated in Kiambu County near Nairobi.

Six huge plantations namely, Kamundu, Ting'ang'a, Kakindu, Doondu, Ruiru Mills and Gulmarg Estates, each with a coffee pulping factory/station are located in Kiambu County.

Collectively, the plantations have the capacity to produce an average of 2500MT of coffee annually. About 50% of the production is attributed to our outgrowers. The clean coffee in assorted grades is offered at Nairobi Coffee Exchange and also exported to European Countries and the United States of America.

In addition, the company owns a coffee curing/milling plant at Kamundu Estate. The mill has a capacity of milling 12MT of clean coffee per hour









In collaboration with a regular coffee buyer, we have put up a nursery school/ day care center to cater to our employees and community needs.

Part of the proceeds generated from our coffee operations has been utilized to support and refurbish a couple of schools within our locality.

MACADAMIA

NUTS

Sasini Fruits and Nuts EPZ Kenya Ltd, our macadamia nuts processing and export company is located in Sasini EPZ Park situated along Kiambu-Githiga- Limuru road.

The facility is registered by the United States of America Food and Drugs Administration (FDA) besides being a member of International Nut and dried fruit Council (INC).

Locally, the company is licenced by Agriculture Food Authority (AFA) and regulated by Export Processing Zones Authority (EPZA). Processing of macadamia in the factory involves quality analysis at receipt, drying, cracking, sorting, packing and dispatch to our customers overseas.

High quality standards are observed right from receipt of nuts in shell to dispatch of kernels ensuring that the farm to plate supply chain under the company is not compromised. The company has invested in the growing of Macadamia nuts with the establishment of nucleus orchards in its Mweiga estate in Nyeri and Kiambu Estates.

The mature nuts in shells are sourced from outgrower farmers. The nuts are processed in our state of the art ultra modern processing factory located within the Export Processing Zone Park within our premises in Kiambu.

The produce is mainly exported to USA, Canada, Europe and Asia.

MACADAMIA BENEFITS

Macadamia nuts have several benefits from consumption including being high in protein and fibre content, zero cholesterol levels, contains no GMO, it is a source of Ptolemaic acid and has the highest levels of monounsaturated fats of any commercial food.




OPERATIONS

As part of our business strategic development and diversification, the need to further address the issue of health concerns and the increasing cases of lifestyle diseases globally was topmost in our list of priorities. And how would we do this? Being an agricultural company with a rich heritage and grounding in crop husbandry, we needed to identify a crop which would offer health benefits to the consumers and Avocado was an easy pick from a range of other crops to supplement the core businesses of tea and coffee, which are also health beverages, given that avocados do well in most of our Kenyan climate.

The Avocado line of business is run by our subsidiary, Sasini Avocado EPZ Ltd, a bona fide licensee of the Agriculture and Food Authority, Horticultural Crop Directorate. We started exporting avocados in 2017. Our nucleus farms are located in Nandi and Kipkebe in the Rift Valley, and in Nyeri and Meru in Central Kenya Highlands which have different climatic conditions but very suitable for growing of Avocados. We have planted our own orchards to enhance and sustain production.

Sasini Avocado EPZ Ltd does the packing of avocados at Sameer Industrial Park along Mombasa Road, which is conveniently located for easy access to the Jomo Kenyatta International Airport in Nairobi for airfreight and to the port of Mombasa for sea freight. The company processes and markets the fruits for export to USA, Canada, Europe and Asia. About 50% of the fruits is sourced from our out-growers.

Our fruits are traceable to the fields where they have been harvested as we have an elaborate traceability system in place. Maximum Residue Levels (MRLs) for the fruits are tested before harvesting commences and we use ISO 17025 certified laboratories to evaluate the MRLs. Our husbandry processes are environmentally friendly ensuring nil or minimal environmental degradation.

We specialize in packing two of the most popular varieties of avocados – the Hass and the Fuerte Avocados. Other varieties like the Pinkerton and Jumbo are packed as per demand by specific markets.

Ambitious to grow the local and national economy, the company excised 20 Acres of its land in Kiambu near Nairobi, to set up an Export Processing Zone (EPZ) to enhance the export of industrial and commercial goods/products and tap into the advantages offered by an EPZ, which are operation in a barrier free environment and long tax holiday/ exemption.

The other benefits offered by an EPZ are the creation of jobs and income generation, development of labour skill sets, foreign direct investment, transfer of technology and expansion of growth from foreign exchange earnings through non traditional exports.

We have over **10,000** small holder farmers who supply us Green Leaf Tea, Parchment Coffee, Avocado and Macadamia. The partnership with the farmers is of a symbiotic nature and very important to us since they contribute to almost 50% of our required factory throughput and hence generate income for farmers, which directly or indirectly supports about 40,000 family members and helps sustain the local economy.

The farmers also access farm inputs, fertilizers, seeds, chemicals, advances and technical support conveniently from us to help them improve their yields and sustain their farming activities.

To enhance our mutual benefit, our farms and by extension, those of our small scale growers have obtained the following certifications:-

- 1. Rainforest Alliance
- 2. C.A.F.E Practices

These have not only enabled our produce to attain international standards but also achieve premiums on the produce, which benefits both us and the out growers.

As mentioned in this document and in fulfilling our corporate citizenship role, we will continue to undertake the corporate social activities which include building and financially supporting schools and hospitals, supplying clean water for both farmers and workers, as well as day care centers / crèches for nursing mothers in the employment of the company are among the other programs that we undertake.

We also have Farmers' Open days, which are events that we have engendered into our annual programme of activities where we interact and discuss with farmers on:-

- Better agricultural practice;
- Reforestation programme and;
- Environment and safety programmes
- We have also extended use of technology through mechanized tea harvesting to some of our out-growers who have opted for this mode of harvesting

We believe the above programmes will improve the livelihoods of our farmers and sustain our business going forward.

Sasini's Corporate Social Investment is focused on ensuring that it provides its large workforce with quality life on its estates. In this regard, emphasis has been laid on quality housing, education and health care services. Sasini's housing policy ensures that workers live in healthy conditions in order to provide their best at work. Sasini ensures that its takes the best possible care of its labour force. In this regard, we provide staff housing for all workers and their families on the estates.

Social amenities are availed in each estate including grocery shops, barber shops, maize milling facilities and staff clubs for after-hours entertainment.

Significant social investment has also been made in ensuring that quality healthcare is provided to all staff. The company maintains a well-equipped medical centre with in-patient and out-patient treatment options. It also maintains three satellite dispensaries with well trained medical personnel and a diagnostic laboratory. The facilities also have ambulances on standby in case critical cases need to be transported to larger health facilities.

Education is the most important investment we can make in the lives of our staff. Sasini has therefore constructed four excellent primary schools and a first class high school, and continues to support them on an ongoing basis.

We also ensure that we provide pre-school opportunities for the younger children and in this regard we have established six day care centers in our tea estates where toddlers are kept busy and fed on a daily basis as their parents work.

Sasini also has a clear policy on Child labour and all employees have been sensitized to the policy. The company does not under any circumstances employ children in any capacity whatsoever.


