The **Data Governance in Africa Initiative** supports a "development-oriented and human-centric data economy and society in Africa." The Initiative is part of a broader strategic partnership between the **African Union** and **European Union** regarding Digital Cooperation and is seen as a key component of the Joint AU-EU Vision for sustained and sustainable economic growth.

The Call for Proposals outlined in this document falls under this Initiative and is part of a larger collaboration between Enabel, HAUS, and ESTDEV and HAUS, respectively the **Belgian**, **Estonian** and **Finnish** development agencies, that are launching a separate, complementary Call with a different set of stakeholders in Africa's digital & data ecosystems.

HAUS and ESTDEV will support private sector actors through capacity building & investment readiness. Enabel's Innovation Hub (Wehubit) will support government institutions, academia, civil society, NGOs, and social enterprises through grants and capacity building.

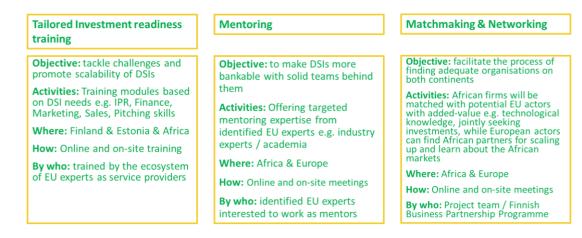


The **objective** of the Call for Proposals is to boost growth by supporting the expansion and sustainable adoption of data-driven Digital Social Innovations (DSIs)¹ in Africa's digital ecosystem, catering to entrepreneurs, startups, and SMEs. It also seeks to attract European and African investors to drive social impact and economic growth while facilitating European actors in finding African partners and understanding African markets.

What is important and necessary for the call for proposal?

- The applicant (s) needs to emphasize alignment with Sustainable Development Goals (SDGs), scalability, understanding of local context, and previous performance.
- > Emphasizing multi-stakeholder involvement, particularly African-European collaboration, impactful initiatives, and innovative strategies is essential for enhancing visibility.

What the Call for Proposals will offer?





Outputs of the Call

- 10 DSIs will undergo tailored investment readiness training and receive mentoring, coaching, and support from experienced professionals, mentors, and peers.
- > The project facilitates pitching, matchmaking, and networking for DSIs to engage with potential investors, partners, mentors, and stakeholders across Europe and Africa.
- The project cultivates a dynamic digital innovation ecosystem in Africa, aligned with the Data Governance in Africa Initiative goals and promoting continent-wide sustainable development.

Thematic scope

Overall, data driven DSIs should help bridge digital disparities, such as urban/rural, gender, and youth divides. Here are some themes they could tackle:

- > E-Health/epidemics (e.g. cross-border health data sharing)
- > Digital inclusion (e.g. addressing youth & gender gaps, digital rights, education)
- Climate change, energy, natural resource management, and climate-smart agriculture
- Financial inclusion, open finance, and banking
- > Connectivity (e.g. last-mile access, infrastructure, regulatory issues)
- Governance (e.g. e-governance, smart cities, transportation, taxation/customs)

¹ In the context of this Call, DSI refers to a data driven new or improved product, service or process that leverages technology to address social or environmental challenges and generate positive societal impact.

Applicant Eligibility

Timeline and Phases

Application is open to both individual organizations and consortiums aiming at scaling up. Consortiums must be led by a private sector entity registered in South Africa, Kenya, Senegal, Zambia, Tanzania, or Botswana. European consortium partnerships are strongly encouraged.
